# AUTO HITS CARRIAGE, KILLING A WOMAN

Mrs. Haslen of Lincoln. N. J.. Thrown from Machine-Two in Carriage Stunned.

DOELGER'S CAR STRIKES BOY

## Chauffeur Sends Auto to Curb to Avoid Collision and Mortally Injures Child.

PLAINFIELD, N. J., Aug. 18.-Mrs. Andrew Haslen of Lincoln was killed this evening in the collision of a runabout automobile and a carriage between Lincoln and Dunellen. In the auto with her was Oscar Harrison of Lincoln, the owner of the machine. The carriage with which the auto collided was occupied by Mr. and Mrs. Arthur Van Arsdale of Prospect Place, Plainfield. Both vehicles were traveling in the same direction. Van Arsdale says that the auto came up so sud-denly behind his carriage that he had no time to pull out of the way. The carriage was demolished and the auto was badly wrecked.

Mrs. Haslen was thrown out into a ditch by the road and she struck on her head as a wheel was torn off the auto by the impact. Her skull was fractured. A passing auto party took her in their car and started for the Plainfield Hospital, but she died before the institution was reached. Harrison was only slightly burt reached. Harrison was only slightly hurt and Mr. and Mrs. Van Arsdale also es-caped serious injury, although both suf-fered from shock. The Van Arsdale carriage was hurled across the road and the occupants fell into the ditch.

into the ditch. Both riders lay stunned into the ditch. Both fuers may stand for a time. Mrs Haslen was about 50 years old, and is survived by a husband and two grown daughters. Mr. Harrison is connected with the New Jersey Central Railroad. He is an old friend of the Haslen family, and this evening invited Mrs. Haslen to take a drive in his automobile. ## Brewer in Car When Child Is Mortally Injured in Yonkers.

Edward Shapiro, the three-year-old son of Solomon Shapiro, a tailor of 65 South Broadway, Yonkers, is dying in St. Joseph's Hospital, this city, as the result of being run down yesterday by the automobile of Peter Doelger, Jr., the brewer. The child has two fractures of the skull. The accident occurred in front of the child's home, and was viewed by his mother, who collapsed. Mr. Doelger was in the automobile.

The car struck a tree after the acci-dent. It is a costly Mercedes and is prob-ably beyond repair. Daniel Dwyer, the chauffeur for Doelger, was arrested on a charge of reckless driving. It was reported at St. Joseph's Hospital

that the child would probably die before morning.

The chauffeur is said to have been forced to drive the car to the curb to avoid a collision with another car.
