

L. G. HOPPE'S TIMES PRIZE

Won the Winners' Race at the Crescent Wheelmen's Meet.

A GREAT CROWD SAW THE CONTEST

The Track Was in Fine Condition and Some Pretty Races Resulted—

Close Finishes by Class

B Riders.

PLAINFIELD, N. J., May 30.—The first race meet of the Crescent Wheelmen of Plainfield this season was held on their new third of a mile oval track this afternoon, in the presence of fully 8,000 persons.

As early as 1 o'clock the crowd began to wend its way to the spacious grounds, a mile outside of the city.

When Starter Chamberlain announced the one-mile novice, at 2:45 o'clock, the grand stand was filled to overflowing.

Summer girls, with their varicolored gowns, and the gallant swains who accompanied them, dressed in white duck or flannel suits, made the scene particularly attractive.

The track was in record-breaking condition, and fast time was made in most of the heats, while the racing throughout was excellent.

The riders suffered intensely from the heat. Not a breath of air was stirring, which helped the crackjacks wonderfully.

The officials who so successfully managed the races were: Referee—George D. Gideon, Chairman League of American Wheelmen Racing Board; Judges—Fred J. Keer, Chairman Racing Board New-Jersey Division; J. C. Tattersall, Secretary-Treasurer New-Jersey Division; S. W. Merrihew, official handicapper, New-Jersey Division; J. S. Holmes, Orange, N. J.; Starter—A. H. Chamberlain, Captain Union County Roadsters, Rahway, N. J.

Several wheeling clubs from New-Jersey and New-York had called runs to the Irvington-Millburn event, and then to Plainfield.

Noticeable among them were seventy-five men of the Union County Roadsters, under command of Lieut. W. S. Martin.

The one-mile novice brought out fifty men, all anxious to become stars, and by the pace cut out by some of them they will succeed.

The races were run off in heats; the first three in each heat ran in the finals.

The Class A men showed their colors in the two-thirds mile scratch, the second event on the programme. "Teddy" Goodman, the pride of the Riversides, made his first appearance on the track this season, and astonished his friends by allowing himself to be "pocketed" in this race.

The final heat in the one-mile novice was the first exciting event of the day. The trial men started off on a funeral loaf, which was kept up until the second lap, when they began to try for positions favorable for the sprint home. S. W. Johnson then set a hot pace, which he easily maintained to the end, winning by four lengths from B. L. Johnson of Somerville, in 2:53 3-5.

The two-thirds mile scratch, Class B, brought the crack-a-jacks out for the first time. Monte Scott, time winner of the Irvington-Millburn, was entered for this race, but his efforts at Millburn had been too much for him. Maddox looked trained to a finish, as did Cabanne.

Helfert cut the pace for the first quarter at a two-minute gait, the rest close up. Steenson came up on the half. As they came up the stretch, it looked like a dead heat between Cabanne and Maddox, so close were they. It was not until the announcer reported that Cabanne was the winner that the crowd was sure of the result. Helfert was a close third. Time—1:40.

Jack cut out the pace in the final heat of the two-thirds mile scratch, Class A, for the first third; but when the spurt for home was made, he was not equal to the task, being beaten out by Hoppe, Hodgson, and Heyer, in the fast time of 1:37 1-5, in the order named.

In the one-mile handicap, Class A, Granger of the Riversides, from 20 yards, overhauled the field in the first half, but the pace was one that killed, and he dropped out. It was run in three heats. The first heat was won by Jacobus of the Montclair Wheelmen from the 100-yard mark. Time—2:15; Cuming of the Crescents second, (120 yards); Powell, New-York Athletic Club, third, (60 yards); E. C. Johnson, Union County Roadsters, fourth, (140 yards,) and W. C. Roome, New-Jersey Athletic Club, fifth, (scratch.)

The second heat was hotly contested from start to finish; no one man seeming to have the advantage, until they came into the stretch, when Hodgson, unattached, came home first, a half wheel ahead of Jack of Reading. Time—2:18 1-5; McGurn was third, Johnson fourth, and McCutcheon fifth.

The third heat was nip and tuck throughout. It was won by Baldwin, (100 yards;) Heyer, (30 yards,) second; Hoppe, (90 yards,) third; Carpenter, (100 yards,) fourth, and Tilford, (100 yards,) fifth. Time—2:16.

The one-mile scratch, Class B, was exciting enough to satisfy the worst "crank" present. It was run in one heat and a time limit of 2:25 was placed. Helfert, as usual, made the going for the first quarter. When Sanger went out at a two-minute clip, Cabanne went out for the third, and the pace he set was a killing one. He, by working hard, maintained the lead to the finish. Brown was a close second, a wheel ahead of Carter. Time—2:38. Although a time limit of 2:25 was placed, Mr. Gideon allowed it to stand.

It was announced at this stage that Starter Chamberlain, than whom there is no better known wheelman in New-Jersey, had been overcome by the heat and was seriously ill. His place was taken by A. M. Franklin of the Brooklyn Bicycle Club.

The final in the one-mile Class A handicap was a "scorcher." The men were well bunched at the half, Bofinger (scratch) being well up. Powell (50 yards) won by a half wheel from Jacobus, (100 yards,) who led Jack (50 yards) easily by two lengths. Time—2:19 2-5.

The sixth event on the interesting programme was the one-mile handicap, Class B. Cabanne (20 yards) and Brown (80 yards) easily caught the field on the first quarter, but dropped out. Helfert (100 yards) and Silvie (120 yards) fought out the last half mile bitterly, Helfert winning by the narrowest margin, Silvie second, Steenson (80 yards) third. Time—2:10 3-5.

After a half hour's tedious race, the two-mile handicap, Class A, was run in one heat. W. C. Roome, New-Jersey Athletic Club, was the scratch man, and the men were strung out at five and ten yards' intervals for 220 yards. Hoppe cut the pace for the first mile, when Roome dropped out. S. W. Johnson started off on the last third for the run home, but was unsuccessful when the spurt came. R. L. Asner, (190 yards,) first; Henshaw, (200 yards,) second; Cobb, (110 yards,) third. Time—4:56 2-5.

The last event on the programme was the New-York Times one-mile race for a fifty-dollar gold medal, competed for by the winners of the first, second, and third prizes in the Class A events. The entries were S. W. Johnson, B. L. Johnson, C. J. Bird, L. G. Hoppe, Elmer Hodgson, and W. Heyer, I. A. Powell, B. L. Jacobus, and C. B. Jack. It was won by L. G. Hoppe of the Liberty Wheelmen, Brooklyn. R. L. Asner of the Allen Wheelmen was second, and B. L. Jacobus of the Montclair Wheelmen third. Time—3:33 2-5.
